LEASE DEED

This Deed of LEASE is made on 09/09/2024 at Imphal between Shri Gurumayum Shanatombi Devi W/o Hidangmayum Devasekhar Sharma a resident of Brahmapur Nagamapal, Imphal West District Manipur P.O Imphal P.S. Imphal, hereinafter called LESSOR on one part.

AND

Guru Charitable Trust Mantripukhri Sponsored Body of North Point Higher Secondary School, Khabam, Imphal East District Manipur represented by its Secretary hereinafter called LESSEE on another part agreed as follows :

- 1) That the Lessor is the Co-pattadar No.2 of the Land under Patta No. 356 (Old) 324 (New) covered by C.S. Dag No.79(Sht-1)/89(Sh-1) measuring an area 0.14569 and 0.26305 situated village No. 005 Khabam.
- 2) That, the Lessee desire to use the above said land of the lessor for running & extension of the North Point Higher Secondary School, Khabam Imphal East District Manipur for a period of 30 (thirty) years.
- 3) That, the Lessee shall pay a sum of Rs. 5000/- (Rupees five thousand) per month to the Lessor as monthly rent.
- 4) That the Lessee shall also deposit a sum of Rs. 1,00,000/- (Rupees one lakh) as security deposit which is refundable after expiry of Lease terms without interest.
- 5) The Lessee shall bear Electricity and Water charges.
- 6) That, the Lessee shall not sublet and repair the Land/building to any third party without the permission of Lessor
- 7) That, the lessee shall not conduct any unwanted service inside the building.
- 8) That, the Lessor accepted all the above terms and conditions purpose by the Lessee.
